Decision

The Control, Ethics and Disciplinary Body decides:

- 1. To order the partial closure of the Bosnia and Herzegovina Football Federation's stadium, which shall consist of at least 2,000 seats, during the next (1) UEFA competition match it plays as host association, for the racist behaviour of its supporters. Said partial stadium closure is suspended for a probationary period of two (2) years, starting from the date of the present decision.
- 2. To fine the Bosnia and Herzegovina Football Federation €10,000 and to ban the Bosnia and Herzegovina Football Federation from selling tickets to its away supporters for its next (1) UEFA competition match, for the racist behaviour of its supporters, throwing of objects, acts of damage and crowd disturbances.
- 3. To order the Bosnia and Herzegovina Football Federation to contact the Romanian Football Federation within 30 days for the settlement of the damages caused by its supporters, i.e. for 39 broken seats.
- 4. The above fine must be paid into the bank account indicated below within 90 days of communication of this decision.
